

FRENCH GRASS WORKS, GALLOWS GORE, WORTH MATRAVERS COMMERCIAL PREMISES £45,000 PA

These substantial commercial premises are situated in a rural location on the road between Langton Matravers and Kingston, about 8 miles from the market town of Wareham. Currently comprising offices with two large workshops at the rear. The building was constructed during the latter part of the 20^{th} Century and has attractive external elevations of natural Purbeck stone. The premises have the benefit of solar assisted energy and are offered on a 5 year lease at a rental of £45,000 per annum. 


